ORDER

Date: 01/06/2020

In view of the pandemic COVID-19 and in the interest of social distancing, following arrangement with regard to payment of maintenance allowance under different heads -

- a) The 2nd party/respondent in a proceeding in consultation with the 1st party/petitioner may submit a '**standing instruction**' to his banker, requesting to credit the directed amount of monthly maintenance from his account into the account of the 1st party/petitioner at regular intervals. Thereafter, he/she shall submit the authenticated copy of such instruction to this court for ready reference.
- b) If the parties fail to comply with the condition (a) above due to technicalities, the 2nd party may deposit the amount directly into the account of the 1st party/beneficiary personally through any convenient mode of transaction.

To facilitate the same, the 1st party/petitioner to the maintenance proceeding shall submit a legible copy of the front page of her/his passbook covering the details of the savings bank account such as the name of the bank, branch, account number, IFSC code, etc into the court as well as to the 2nd party/respondent.

- c) The parties to the proceeding shall invariably communicate about such transaction to this court so that the transaction particulars could be recorded for reference. Failure to communicate the transaction particulars to the court (even if made), may invite procedural consequences.
- d) The 1st party/petitioner to the proceeding may submit her/his account details as per the model form attached herewith in the following email:
