**ORDER No.- 182**

Dated: Nalbari, the 10<sup>th</sup> July, 2021

In view of the Hon'ble Gauhati High Court's Notification No. 61 dated 9<sup>th</sup> July, 2021, the courts of the Nalbari District Judiciary will be resumed the limited court functioning with effect from 12<sup>th</sup> July, 2021 and take up the cases mentioned in the Hon'ble Gauhati High Court's Notification No. 61 and the cases pending against U.T.P.

Entry of outsiders shall be strictly prohibited in the court premises unless specially directed by the concerned courts or unless personal appearance of a party is required in a judicial proceeding. No person except the learned Advocate/parties appearing in person, who are to address arguments, shall be permitted in the court room. The learned Advocates, appearing in person, who are not vaccinated with one or both doses of Covid-19 vaccine, will go for RAT as per Govt. guideline.

All applications for filing and copy, receipt and other petitions must be submitted in the respective counter (e-Sewa Kendra). While filing applications for new case, copy etc.; advocates must have to send the soft copy of the hard copy to the specific email id. The soft copy should be the exact replica of the hard copy. They are advised to drop the hard copy in the specific drop box..

Due to shortage of staff, the staff who are vaccinated with one dose or both doses of Covid-19 vaccine will attend office daily for smooth functioning of the works of all sections of the office and courts. However, the concerned presiding officer of Addl. District and Sessions Judge, the Civil Judge and Asstt. Sessions Judge, the Munsiff No-1 and the Munsiff Magistrate Tihu will call the non-vaccinated staff on duty, according to their requirement. Non vaccinated staff will go for RAT as per Govt. guideline.

The Chief administrative Officer, Sheristadar, Head Assistant of all the establishment will take steps for daily sanitization of court rooms after court hours.

The Court and offices will function till 1 P.M as per Govt. Order No. ASDMA.28/2021/148 dated 6<sup>th</sup> July, 2021.
