The quotations should have to reach the Office of the undersigned on or before **02th June/2020**.



Terms and Conditions are as follows:


1. Only Government Registered Suppliers/Firms/Shop having their offices within the territory of Nalbari Municipality are eligible to submit the quotation.

3. The rate of the articles should be quoted against the items and price quoted should be inclusive of all taxes. However, GST rate is to be shown separately against the items. The price quoted should not exceed the maximum retail price of the articles.

4. Rates quoted shall be valid for a period of one year from the date of awarding the contract.
5. Duplicate/Sub-standard items will not be accepted anyway.
6. Sample of articles to be supplied shall have to be furnished along with the Quotation.
7. The undersigned has reserved the right of rejecting the quotation without assigning any reason thereof and the undersigned is not bound to accept the lowest rate of any quotation if it arises in course of tendering. The decision of the undersigned will be the final.
8. Quotations submitted after the stipulated time will summarily be rejected.


