3. Candidates must not be less than 18 years of age or more than 43 years in case of General Candidates, 45 years for OBC/MOBC and 47 years for SC/ST as on the last date of submission of the application.

The application with self attested copies of all testimonials regarding Educational Qualification, Age, Caste, along with three (3) copies of recent passport size photographs, duly signed by the candidate on the reverse side should reach the office of the undersigned within 02-09-2020 by 4:15 PM. No application will be entertained after the scheduled time.


