6. Prices once approved will remain valid during the scheduled delivery period. Increase of taxes and other statutory duties will not affect the price during this period. The supplier will be responsible for any increase of taxes and duties.

7. The payment shall be made on completion of supply and installation of above noted works and acceptance with full satisfaction and on production of the following:

- (a) Bill in triplicate
- (b) Bank Account details
- (c) Delivery challan dully signed by the consignee.

8. In the event of breach of any terms and conditions or delay or default the purchase order will be terminated.

9. Conditional tenders are liable to be rejected.

10. Quotations submitted after the stipulated time will summarily be rejected.

11. In case the successful bidder supplies sub-standard materials, its tender shall be cancelled. Thereafter, next successive bidder may be considered.
